INFORMATION FOR THE APPLICANT

1. Continued illegal residence in Norway

NOAS is not part of the Norwegian immigration authorities. If your application for asylum has been rejected and you have missed the deadline for departure, you will still be illegal in Norway, even if your case is under consideration by NOAS.

2. Information about case processing

NOAS will assess your case as soon as we have the capacity. You will be notified if NOAS can assist you or not. The average processing time is four months, but it may take longer.

You must obtain the documentation of importance for your case.
